This has included enhanced staff training, streamlined intake processes, creation of an art therapy room and upgrades to our reception area and staff lounge. When we were confronted with staffing changes, we took the opportunity to reorganize our mental health services into one department with three divisions: clinical, school-based and day treatment services. This helps us cross pollinate ideas and create a staffing structure that supports succession planning.

Mental Health Counseling

NYFS offers effective, culturally-sensitive individual and family counseling to people at all ages and stages of life. Low-income clients are eligible to receive services on a sliding-fee scale to ensure that everyone who needs our help can receive it. Our licensed therapists also work with local school districts and staff to support youth in both their school and home environments.

54% of clients reported progress meeting over 50% of their treatment goals



Day Treatment Services

Our day treatment programs serve youth in grades 5-12 struggling with mental health issues. They receive mental health support and counseling in connection with academic instruction during the school day. Our immediate goal is to support behaviors that minimize mental health symptoms. Our long-term objective is to increase academic success and promote lasting changes that are good for the child, school and community.

74 % of youth returned to a less restrictive school setting within 15 months



Community Service Programs

NYFS community service programs focus on three core areas that are critical to long-term success: academic achievement, employability and citizenship/life skills. Through the Diversion Program and Senior Chore Program, we help youth set and achieve goals that lead to a better, more successful future than they had previously imagined..

92% of reporting seniors said the Senior Chore Program helped them live independently


